The applicant shall employ an employee for the purpose of contract work, Electrical Supervisor holding valid Supervisor Permit Grade 'B' or Grade 'A'  
The applicant shall employ an employee for the purpose of contract work, Electrical Wireman holding valid Electrical Wireman Permit  
The applicant shall possess Instruments ( With Test and Calibration Certificates ) The applicant shall possess the Electrical Tools  
The applicant shall possess the drawing and office facilities. The applicant shall possess the library of books  
The partner ship firm shall register partner ship deed under Kerala Registration Act..
