The candidate should be in the age limit between 18 - 65

Eligibility : The candidate should have passed S.S.L.C. Examination and
Those who have five year practical experience with wireman permit (four years after taking wireman permit through examination)
or
Those who have two years practical experience after obtaining wireman permits with ITI, NCVT and KGTE (Exempted Category)
or
SSLC Course completed and having 10 years experience after obtaining "C" Class Electrical Contractor Licence

How to renew the # Electrical Supervisor Grade B Permit

Permit should be submitted for renewal before one month of "valid upto" date
Permit become 'lapsed' after 3 months of the "valid upto" date
Permit lapsed for more than 10 years will not be revalidated

How to revise the scope of Electrical Supervisor Grade B permit

Important :

For those who have obtained Electrical supervisor permit grade B under the Exempted Category (Exemption from Electrical Supervisor Written examination)
No application for revision will be entertained within a period of one year from the date of issue of the permit or Date of last interview for scope revision.

For those who have obtained Electrical supervisor permit grade B of scope :
All LT / MV Electrical Installations upto 50 k W including Generator installations upto 50 kVA
through Electrical Supervisor Grade B written and practical examination,
Application for scope revision will be entertained after 5 years from the date of issue of the permit
and Scope revision is limited to the scope of
All LT / MV Electrical Installations upto 150 k W including Generator installations upto 150 kVA
